#### STATUS OF "LOST TRAILS AT THE COVE" HURRICANE DEVELOPMENT

A developer from Washington City wants to build a 340 acre development that would include an Old West town filled with shops and restaurants, a wedding chapel, Spanish gardens, equestrian center, an indoor dinner show with 1,200 seats, hotel, RV park and daily entertainment. It is porsed to be located north of 600 North at approximately 2000 West. The area is currently zoned as single family residential up to 4 units per acre. Therefore, a zoning change is required.

There was a meeting with the Hurricane Planning and Zoning Commission on 10 Jan. Most of the people in meeting talked against the change in zoning. The Commission voted to recommend that the Hurricane City Council deny the amendment change and leave the General Plan as is. The minutes from that meeting can be seen at:

# Planning and Zoning Minutes

There was a public meeting with the Hurricane City Council on 7 Feb to discuss the proposed development. The results were reported in the St George news:

## St George News Article

The majority of people spoke against the development. The Council decided to postpone the decision to their next meeting on 21 Feb. They wanted to do more research and get more input from the developer. There will not be another public hearing.

## City Council

The Developer did not show up for the City Council meeting on 21 Feb. He submitted a request to the City for a continuance because he did not have answers to the questions that have been raised. The Council granted the continuance.

If you would like to provide input to the City Council about this, mark your calendar to attend the next City Council meeting on 7 March at 6 pm. It it expected to be held in the Fine Arts Building but that may change.

Based on the comments from the City Council members at the 7 Feb meeting, it looks like they may go against the recommendation of the Planning and Zoning Commission and approve the development. This is something the City Council does often.

#### CITY COUNCIL AND PLANNING COMMISSION

23 Jan 2019 Planning Commission Meeting

An assisted living facility was approved for 7.83 acres located on the north side of 600 North at approximately 2270 West.

A 45 space RV Park located at Crimson Ridge Drive and Old Highway 91 was approved.

Phase I of Desert Fields Townhomes, 64 townhome units location west of 2460 West and south of 350 North (Rock Solid Homes) was approved with conditions.

17 Jan 2019 City Council Meeting

UDOT Project Manager Kim Manwill gave a status update to Council regarding the Southern Parkway project. Construction is scheduled to begin later this sum-

mer. This project is estimated to take 18 months before it is completed. There will be four separate interchanges along this route. UDOT is in the process of securing all the necessary parcels for these structures. Construction will begin at the south end of the Sand Hollow area then move towards 3000 South. Mr. Manwill gave another update to Council regarding the proposed Exit 16 project on I-15. UDOT has hired a consultant to facilitate the different studies so this project can move forward. There will be improvements required along SR-9 and the possibility of another interchange structure to handle the traffic.

Approved a preliminary plat for Silver Leaf Townhomes, a 40 lot townhome project at approximately 190 North 400 West.

# Red Mountain 55k, 30k & Dirty Hurty Half Marathon

2 March 2019.

The 2019 Red Mountain 55k, 30k, and Dirty Hurty Half Marathon trail races course incorporate the scenic dirt trails of the Santa Clara

Desert Reserve located in the west central portion of Washington County, directly southwest of the communities of Ivins and Santa Clara and east of the Shivwits Indian Reservation. The races course starts on Gate's Lane Bridge across from the historic Jacob Hamblin home and quickly turns onto a BLM service road and climbs up to the single track tails in the Santa Clara Reserve. The course winds in clover fashion back into the Cove Wash Trail-head Aid Station 4 times before heading to the finish at Unity Park, Ivins, UT.

# Lake to Lake Relay

2 March 2019. A 50-mile team relay from Gunlock Reservoir to Sand Hollow Reservoir. The running route will take runners through scenic landscapes of Southern Utah along city trail systems and back roads.

Teams will consist of 5 people (Open Men, Open Women, and Co-Ed) with each individual completing a minimum of two legs (roughly 5 miles each) of the relay. For the co-ed team, you need at least 2 women on the team. There will also be 2-person teams as well as an Ultra event.
