#### WASHINGTON COUNTY LIBRARIES / CAROL SAPP

Garret Bangerter was present representing Carol Sapp for the Utah Homebuilders' Association. He

said the Homebuilders' Association wants to contribute ten (10) books entitled *Portrait of Loss*,

Stories of hope, and ten (10) DVD's depicting scenes from the January 2005 flood, to the five (5)

branches of the Washington County Public Library. He said it was the hope of the Homebuilders'

Association that the residents of Washington County, regardless of their means, would have the

opportunity to view the DVD and read the book that portrays the local heros and citizens giving their

all during the challenging times they faced in January of 2005.

Mr. Bangerter said the Southern Utah Homebuilders' Association is proud to be a member of

Washington County and in behalf of more than seven hundred (700) industry businesses, he

expressed appreciation for a job well done.

### DISCUSSION / PROPERTY TAX RELIEF FOR WASHINGTON COUNTY FLOOD

#### VICTIMS / ART PARTRIDGE

County Assessor Art Partridge said State law requires that all property owners pay taxes on the

assessed value of their property (value as of January 1 of each year). The recent flood in Washington

County occurred on January 10 and 11, 2005, so the Assessor's Office has made an attempt (with

the support of Brad Last and our other political representatives in the legislature) to sponsor a bill

to provide relief from property taxes on those properties owned by Washington County flood

victims. He noted that the bill requires that damage must occur from a natural disaster, and it defines

what those natural disasters are. The loss in value must be at least thirty percent (30%) of the taxable

or market value of the property. The law provides that the owner must file an application with the

County Board of Equalization within forty-five (45) days of the natural disaster. Mr.

a letter was sent from the Assessor's Office to all those who they knew had sustained flood damage.

(During the flood, a hotline was set up for flood victims to call in and report their damage.) Dave

Watson, president of the relief fund in Washington County, provided the County with a list of names

his agency had collected. Mr. Partridge noted that there was no duplication between the two lists.

The known flood victims were provided with a form and instructions on how to complete the form.

They have until April 30, 2005, to file an application in order to be within the forty-five-day

requirement.

Chairman Eardley commended Mr. Partridge for perceiving the need for this bill. It assists people

who have lost homes and property and corrects an injustice that would otherwise have occurred as

a result of the flood.

bid was by Golf Services Group, Inc., of Omaha, Nebraska. Their proposed bid was \$5,741,405.30,

approximately \$200,000 beneath the engineer's estimate for this project.

Dixie Springs SID area to appear before the Board and present reasons why an adjustment should

be made to their assessment. An assessment list will be provided to the property owners showing

how much each of the properties will be assessed for the improvements. The above Resolution calls

for the Board of Equalization to take place on May 3 and 4, 2005, from 7:00-8:00 p.m. The Board

will comprise Chairman James J. Eardley, David Patterson and Ron Whitehead. Mr. Bronson said

the critical issue is to establish the assessment amount.

Mr. Bronson noted changes in the figures presented in the Resolution before the Commission and

said the total cost of the project using the bid from Golf Services Group, Inc., including Schedule

A and all other items contemplated in the Special Improvement District (SID) No. 2004-1, will be

\$11,478,077.00. That cost will be divided among 542 lots, resulting in a total assessment per lot of

\$21,177.00. He noted that for comparison, when the SID was created the estimated cost of the

improvements totaled \$11,641,077.00, and the cost per lot was estimated at \$21,478.00. Mr. Bronson noted that a number of lots had prepaid \$2,000.00 toward the assessment. This amount

will be deducted from the \$21,177.00 assessment, resulting in an assessment of \$19,177.00 for those

lots that prepaid. He said this list will be prepared and distributed within a few days.

#### INTERLINX COMMUCATIONS, LLC, AND WASHINGTON COUNTY

ITS Director Merle Ireland said many meetings have been held with Interlinx and its staff. The high

speed fiber-optic network will bring high performance networking redundancy to Washington

County at a reasonable price. She said it would assist with issues the library, the Dixie Center, the

County Attorney's office, the County Administration Building and the Boulevard Building are

having. Network Manager Jim Speth gave the Commission a PowerPoint presentation demonstrating the need for and advantages of the Interlinx system. Chairman Eardley noted that this

is a major upgrade for the County. Mr. Speth said the system will bring in businesses and increase

tourism, and as a result, will create monetary increase for Washington County. Commissioner

Gardner congratulated the ITS Department on acquiring this service at a price the County could

afford.

CONSIDER FINAL PLAT APPROVAL OF THE FORT HARMONY SUBDIVISION,

CONTAINING 6 LOTS, GENERALLY LOCATED 3 MILES EAST OF NEW HARMONY.

#### ELDON SCHMUTZ, APPLICANT. Planning Commission Approved 6-0

Deon Goheen said the platting on this project meets the requirements of the Subdivision Ordinance.

The Planning Commission unanimously recommended final approval for the Fort Harmony

Subdivision (containing six [6] lots), and waived the curb and gutter requirement on the east side of

the road. On the developed side there would be a requirement for curb and gutter.

Chairman Eardley proposed that the curb and gutter requirement be waived on the west side of the

road as well, in keeping with the agricultural flavor of the area and to contain costs.

subdivision. One lot is being used for the old Fort Harmony site and the other lot will be sold to an

adjacent property owner, thus maintaining the five (5) acre lot density. Approval by the Planning

Ms. Goheen said the School District was planning on purchasing twelve (12) acres of land from

Staheli Minor Subdivision for a new school site. This area will soon be annexed to Washington

City—it is within its area of influence and on a County island between St. George City and

Washington City. The land will continue to be used as farmland, although a zone change is needed

to make it compatible with the surrounding area. The Planning Commission unanimously recommended approval of the Staheli Minor Subdivision subject to meeting the design standards of

the County. Washington City should also be involved with the School District's planning process

for the new school. The County is not able to provide water or sewer service in this area. If

approved, this process is for platting purposes only.

dissolving the SSD at this time would not be advantageous. She noted that with the formation of

Apple Valley as a town, Mayor Reep and those working with her have a lot to do. Taking on the

additional responsibility of the fire department would be difficult.

Commissioner Gardner commended the Smithsonian SSD for the work it has done in the past.

Chairman Eardley said the Resolution provides a transition step for the town.

#### SMALL CITIES PROGRAM YEAR 2005-06 / JOHN WILLIE

Chairman Eardley opened the second public hearing for the Community Development Block Grant

(CDBG) program. Chairman Eardley stated that this hearing was being called to allow all citizens

to provide input concerning the projects that were awarded under the 2005-2006 Community

Development block Grant Program. It was explained that the grant money must be spent on projects

benefitting primarily low and moderate income persons. The County has amended its capital

investment plan and decided to apply for funds on behalf of the following: upgrading of County

facilities to accommodate the disabled in the amount of \$80,000.00; remodeling and upgrading at

the Enterprise Senior Citizen's Center. The ADA grant was approved and the grant for the

Enterprise Senior Citizen's Center was put on hold pending final allocation of available funds. Mr.

Willie said word has been received that these funds in the amount of approximately \$50,000.00 will

be available.

Chairman Eardley explained the project to those in attendance. He then asked for any comments,

questions, and concerns from the audience. There were no comments or questions.

Chairman

Eardley stated that copies of the capital investment plan are available if anyone would like a copy.

He then closed the public hearing.

# PUBLIC HEARING / TO RECEIVE PUBLIC INPUT REGARDING THE REQUEST FOR

### FUNDING FROM THE PERMANENT COMMUNITY IMPACT BOARD FOR IMPROVEMENTS TO THE HURRICANE SENIOR CENTER / JOHN WILLIE

Chairman Eardley opened the public hearing. John Willie said CDBG block grants run for a

maximum period of two (2) years. This item for remodeling and new construction at the Hurricane

Senior Center would take longer than two (2) years. The County has therefore applied to the

Community Impact Board (CIB) for a grant to do this work. This Board receives and expends

mineral royalties throughout the State. Washington County does not participate extensively in this

program because it does not have a lot of mineral monies. A grant has been requested in the amount

of \$665,000.00. Mr. Willie said the CIB does not always approve grants of that size, but they do at

times make partial grants and low or zero interest loans for long periods of time which would exceed

the two (2) years the CDBG allows. He said he and Commissioner Gardner would meet before that

Board later this week and determine its response.
